



Pursuant to Article 1.5 and 20.12a of the Election Law of Bosnia and Herzegovina (“Official Gazette of BiH”, no. 23/01, 7/02, 9/02, 20/02, 25/02, 4/04, 20/04, 25/05, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08, 32/10, 18/13, 7/14 and 31/16) and Article 18 of the Rules of Procedure of the Central Election Commission of Bosnia and Herzegovina (“Official Gazette of BiH”, no. 50/07, 33/09, 24/13 and 32/14), and following consultations with the Ministry of Foreign Affairs of Bosnia and Herzegovina, the BiH Central Election Commission has at 8<sup>th</sup> session held on March 7, 2018 adopted

**DECISION**  
**on diplomatic-consular representation offices of Bosnia and Herzegovina in which**  
**organization of the voting for the 2018 General Elections is planned**

**Article 1**  
**(Diplomatic-consular representation offices of Bosnia and Herzegovina in which organization**  
**of the voting is planned)**

Organization of the voting for the 2018 General Elections in Bosnia and Herzegovina for the citizens of Bosnia and Herzegovina, who have the right to vote and reside abroad, is planned in the following diplomatic-consular representation offices of Bosnia and Herzegovina (hereinafter: DCRO BiH):

**Article 2**  
**(Number and arrangement of polling stations at DCROs BiH)**

The Central Election Commission of Bosnia and Herzegovina shall define the accurate number and arrangement of polling stations at the DCROs BiH by a separate regulation in accordance with the number of voters registered to vote in person at a DCRO BiH.

**Article 3**  
**(Final decision on DCRO BiH in which voting shall be organized)**

(1) The Central Election Commission shall pass the final decision on DCROs BiH in which the voting will be organized after expiry of the deadline for registration of voters to vote at the DCROs BiH.

(2) The BiH citizens, who apply to vote in person at DCROs BiH referred to in Article 1 of this Decision, shall be eligible to vote by mail if a DCRO BiH did not meet the conditions for organization of the voting.

**Article 4**  
**(Entry into force and publication)**

This Decision shall enter into force on the eighth day following its publishing in the Official Gazette of BiH, Official Gazette of FBiH, Official Gazette of RS and the Official Gazette of the District of Brčko of BiH, as well as on the website of the Central Election Commission of Bosnia and Herzegovina [www.izbori.ba](http://www.izbori.ba).
