



I N S T R U C T I O N on Amendments
to the Instruction on determining qualifications, number, appointment, dismissal and
training of members of the election commission of basic constituency Bosnia and
Herzegovina

Sarajevo, January 2018

Pursuant to Article 2.9, Paragraph (1), point 2, Article 2.2, paragraphs (3) and (4) and Article 2.12, paragraphs (2), (3) and (5) of the Election Law of Bosnia and Herzegovina (Official Gazette of BiH, Nos. 23/01, 7/02, 9/02, 20/02, 25/02, 4/04, 20/04, 25/05, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08, 37/08, 32/10, 18/13, 7/14 and 31/16), the BiH Central Commission of Bosnia and Herzegovina has at its 3rd session held on January 25, 2018 passed the following

I N S T R U C T I O N

on determining qualifications, number, appointment, dismissal and training of members of the election commission of basic constituency Bosnia and Herzegovina

Article 1

In the Instruction on determining qualifications, number, appointment, dismissal and training of members of the election commission of basic constituency in Bosnia and Herzegovina (Official Gazette of BiH, Nos. 57/17 and 60/17) in Article 2, paragraph (3), which shall become paragraph (4) upon these amendments, after the words “180 ETCS” the words “without election-related experience prescribed by paragraph (2) herein” shall be added.

Article 2

In Article 3, paragraph (1) after the words “BiH Election Law” the words “or unless there are no candidates to meet requirements set forth in Article 2, paragraph (1), point b) of this Instruction” shall be added.

Article 3

In Article 7, paragraph (1), point a) the words “(media-TV, radio, daily papers)” shall be replaced with the words “website and media (TV, radio, daily papers)”.

Article 4

In Article 10, paragraph (1), Item b) shall be amended and shall read:

“b) Questionnaire on details of the candidate-appointed member of election commission (Questionnaire on details of the candidate-appointed member of election commission is an integral part of this Instruction)”.

In the same Article and Paragraph, in Item c) the first sentence shall be amended to read:

“c) Evidence of professional qualification of the candidate-appointed member of election commission, meaning a certified diploma.”

In the same Article and Paragraph, in point d) in the first sentence after the word “experience” the words “of the candidate” shall be added.

In the same Article and Paragraph, point f) shall be amended to read:

“f) statement on ethnic orientation of the candidate-appointed member of election commission from the latest population census conducted in Bosnia and Herzegovina, personally signed and certified by the relevant authority”.

In the same Article and paragraph, in Item g) after the word “BiH” the words “which is the integral part of this Instruction, personally signed and” shall be added.

In the same Article, in paragraph (2) after the word “authority” the words” which this authority shall deliver also to candidates who participated in the process of appointment of the members of the election commission” shall be added.

Article 5

This Rulebook shall enter into force on the eighth day following its publishing in the Official Gazette of BiH, Official Gazette of FBiH, Official Gazette of RS and the Official Gazette of the District of Brčko of BiH, as well as on the website of the Central Election Commission of Bosnia and Herzegovina, www.izbori.ba.
