

In accordance with Article 2.9 paragraph (1), item 9 and Articles 5.29 and 5.29a of the Election Law of Bosnia and Herzegovina ("Official Gazette of BiH", no. 23/01, 07/02, 09/02, 20/02, 25/02, 4/04, 20/04, 25/05, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08 and 37/08), the Central Election Commission of Bosnia and Herzegovina, at its 66th session held on October 20, 2008, p a s s e d the following

DECISION
on establishing and announcing the results of the 2008 local elections

Article 1

The Central Election Commission of Bosnia and Herzegovina shall establish and announce the results of the 2008 local elections for:

- a) Municipal Councils/ Municipal Assemblies,
- b) Municipal Mayors,
- c) the Assembly of the District of Brčko of Bosnia and Herzegovina,
- d) the City Council of Mostar,
- e) the Assembly of the City of Banja Luka, and
- f) the Mayor of the City of Banja Luka.

Article 2

A detailed tabular overview of the voting results for each electoral level referred to in Article 1 of this Decision, by electoral units, polling stations and political subjects and candidates shall be a constituent part of this decision.

Article 3

(1) Upon establishing and announcing the election results, a request for a recount of votes may be submitted to the Central Election Commission of Bosnia and Herzegovina, within the deadline of three days from the day the election results referred to in Articles 1 and 2 of this Decision were established and announced, in the manner and form established by the provisions of Article 5.30 paragraph (4) of the Election Law of Bosnia and Herzegovina.

(2) The request for a recount of ballots shall be submitted directly in the headquarters of the Central Election Commission of Bosnia and Herzegovina, Mula Mustafa Bašeskije 6, Sarajevo, or via fax: 033/251-329 or 033/251-310.

Article 4

This Decision shall enter into force on the day of its adoption, and shall be published on October 20, 2008 at 2:00 p.m. on the website of the Central Election Commission of Bosnia and Herzegovina, www.izbori.ba. It shall be considered that this Decision was delivered to all participants of the election process on the day of its publication.

LEGAL REMEDY: In accordance with Article 6.9 paragraphs (1) and (2) of the Election Law of Bosnia and Herzegovina, an appeal may be submitted against this Decision to the Appellate Division of the BiH Court of Bosnia and Herzegovina, within the deadline of two days from the day this Decision was published. The appeal shall be submitted through the Central Election Commission of Bosnia and Herzegovina, directly in the headquarters of the Central Election Commission of Bosnia and Herzegovina, Mula Mustafa Bašeskije 6, Sarajevo, or via fax: 033/251-329 or 033/251-310.
