DECISION

LEGAL REMEDY: In accordance to Article 6.9, paragraph (1) and (2) of the Election Law of Bosnia and Herzegovina this Decision can be appealed with the Appellate Division of the Court of Bosnia and Herzegovina within two days following the day of its publication. The appeal is submitted through the BiH Central Election Commission, directly in the seat of the BiH Central Election Commission, 6 Mula Mustafe Bašeskije Street or by fax on number 033/251-329 or 033/251-310.
