DECISION ON NAMES AND MARKS OF BASIC CONSTITUENCIES AND ELECTORAL UNITS OF CITY AREA OF THE CITY OF MOSTAR

Article 1 (Scope)

The Decision on names and marks of basic constituencies and electoral units of city area of the City of Mostar (hereinafter: the decision) regulates names and marks of basic constituencies and electoral units of the city area of the City of Mostar used for drafting the Central Voters' Register, production of polling material and all other activities necessary for the conduct of elections.

Article 2 (Names and marks of basic constituencies)

Names and marks of basic constituencies shall include municipality, city and Brčko District of BiH as follows:

Article 4
(Use of names and marks of basic constituencies)

The names and marks of basic constituencies referred to in Articles 2 and 3 of this Decision shall be used exclusively for the purpose of conduct of elections.

Article 5
(Ineffectiveness)

Effectiveness of the Decision on names and marks of basic constituencies (Official Gazette of BiH, number: 32/16) shall be terminated on the day of entry into force of this Decision.

Article 6
(Entry into force and publication in Official Gazettes)

This Decision shall enter into force on the day of its enactments and shall be published in the Official Gazette of BiH, the Official Gazette of FBiH, the Official Gazette of RS, the Official Gazette of BiH District of Brčko, and on the website of the BiH Central Election Commission, www.izbori.ba.
