on conditions and procedures for accrediting election observers in Bosnia and Herzegovina

Pursuant to Article 2.9, paragraph (1), item 2, and having regard to Article 17.10, paragraph (2) of the Election Law of Bosnia and Herzegovina ("Official Gazette BiH", nos. 23/01, 7/02, 9/02, 20/02, 25/02, 4/04, 20/04, 25/05, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08, 37/08, 32/10, 18/13, 7/1431/16 and 41/20) the Central Election Commission of Bosnia and Herzegovina, at its 17<sup>th</sup> session held on May 4, 2022, adopted the following

### INSTRUCTION

on conditions and procedures for accrediting election observers in Bosnia and Herzegovina

#### **CHAPTER I. INTRODUCTION**

## Article 1 (Scope)

The instruction on conditions and procedures for accrediting election observers in Bosnia and Herzegovina (hereinafter: the Instruction) shall lay down:

- a) the procedure of submitting requests for accreditation and the criteria for accrediting election observers (Article 17.3, Article 17.4, paragraph (1) and Article 17.5, paragraphs (1) and (2) of the BiH Election Law),
- b) the deadlines for submitting the application and the deadlines for taking a decision on the application (Article 17.7 of the BiH Election Law),
- c) considering application for accreditation of election observers (Article 17.10, paragraph (2) of the BiH Election Law)
- d) design, contents and distribution of the accreditation cards (Article 17.6 of the BiH Election Law),
- e) access of the accredited observer to the location of observing election related activities (Article 17,1, paragraph (2) of the BiH Election Law),
- f) revoking the status of an observer (Article 17.10, paragraph (1) of the BiH Election Law), and
- g) the design of the accreditation application and the accreditation card (Article 17.6 of the BiH Election Law).

### Article 2 (Definitions)

Certain expressions used in this Instruction shall have the following meaning:

- a) an **observer** means a representative of a political subject, representative of an association and an international observer accredited in accordance with the provisions of this Instruction,
- b) an **association** means an association or foundation established in accordance with the laws on associations and foundations,
- c) an **international observer** means a representative of international government and international nongovernment organization, a representative of a foreign government and election officials, and
- d) an **accreditation card** means a document issued by the BiH Central Election Commission according to which the observers exercise their right to observe electoral activities.

### CHAPTER II. RECEIVING THE APPLICATION AND THE CRITERIA FOR ACCREDITING ELECTION OBSERVERS

### Section A. Observers of political entities

#### Article 3

(Receiving application for accreditation of political entities – (Article 17.5 of the BiH Election Law)

- (1) The representatives of political entities, certified by the Central Election Commission of Bosnia and Herzegovina (hereinafter: the BiH Central Election Commission), shall submit the application form for accreditation of the observers to observe work of the Central Election Commission of Bosnia and Herzegovina and work of the Main Counting Center to the Central Election Commission of BiH. The representatives of political entities shall submit the application form for accreditation of observers to observe work of the election commission, Center for voters' register, work at the polling station and other places of electoral activities to the election commission in the basic constituency within the constituency for which they are standing for the election.
- (2) The accreditation application form submitted by a political entity to the BiH Central Election Commission shall be found valid only if signed by persons, who are listed as persons authorized for representation in the application for verification of candidacy and whose signature is deposited with the BiH Central Election Commission.
- (3) The BiH Central Election Commission shall communicate with political entities exclusively through the head office of the political party, coalition, independent candidate or lists of independent candidates or through a person authorized for representation before the BiH Central Election Commission.
- (4) The accreditation application form submitted by the political entity to an election commission in the basic constituency within the constituency for which it stands for the election, shall be found valid only if signed by persons, who are listed as persons authorized for representation in the application for verification of candidacy and whose signature is deposited with the BiH Central Election Commission or an election commission.
- (5) A political entity shall submit the contact details (address, telephone/fax number and e-mail) together with the application form referred to in paragraph (1) of this Article.
- (6) The application form for accrediting political entities and the rules of conduct form, as well as the statement on the secrecy of the vote, shall be available at the BiH Central Election Commission and the election commissions.
- (7) Accompanying the application form referred to in paragraph (2) of this Article, a political entity shall complete a list of nominated observers, containing name, last name, number of a valid ID card, national identification number, as well as rules of conduct form with signed statement on secrecy of voting for each nominated observer.
- (8) The right of accreditation for observation of electoral activities referred to in paragraph (1) of this Article shall have political entities that are on the list of political entities determined by the Central Election Commission of BiH according to the procedure applicable to nominating members of polling stations

#### Section B. Observers of associations

#### Article 4

## (Receiving the application for accreditation of associations – Article 17.1, paragraph (1) of the BiH Election Law)

- (1) The representatives of association shall submit the application form for accrediting observers to observe all electoral activities to the BiH Central Election Commission.
- (2) In the application form the association shall indicate:
  - a) Electoral activities it wishes to observe,
  - b) Contact details (address, number of telephone, fax and e-mail),
  - c) Basic constituencies in which it wishes to observe electoral activities,
  - d) Number of observers, and
  - e) The reason why it wishes to observe the electoral process.
- (3) The request referred to in Paragraph (2) shall also include documents specified under Article 17.4, Paragraph (1) items 1) and 2) of the Election Law of BiH.
- (4) Together with the application the association shall provide:
  - b) List of nominated observers containing names and last names, numbers of valid ID card and national identification number of the observers,
  - c) An excerpt on registration of the association in the registry of associations with competent body, which cannot be older than 60 days, and
  - d) Rules of conduct form and the statement on respecting secrecy of the vote.
- (5) Association shall apply separately for each basic constituency in which it wishes to observe electoral activities.

#### Section C. International observers

#### Article 5

# (Receiving the application for accreditation of international observers – Article 17.3 of the BiH Election Law)

- (1) The representatives of the international observers shall submit the application for accreditation to the BiH Central Election Commission.
- (2) Together with the application form representatives of the international observers shall indicate contact details on the application and shall complete the list of nominated observers, containing name, last name, country that issued the passport and the passport number.
- (3) In their applications, representatives of international observers shall indicate electoral activities they wish to observe. Representatives of international observers may observe indicated electoral activity in all basic constituencies of their choice.
- (4) A representative of an international organization shall sign a statement on the application form for accreditation that the said organization does not perform any activity on behalf of a political entity and that it shall adhere to the provisions of the BiH Election Law.
- (5) Accompanying the accreditation form the international observers shall submit a document, signed by the authorized person, giving the reasons why they are interested in observing electoral process in BiH.

### Section D. Observers at diplomatic and consular offices of Bosnia and Herzegovina

# Article 6 (Submitting the application)

- (1) Political entities, associations and international observers shall submit application form for accreditation of their observers to observe elections at a polling station designated for voting of citizens of Bosnia and Herzegovina (hereinafter: BiH citizens) at the diplomatic and consular offices of Bosnia and Herzegovina (hereinafter: DCO BiH) directly to the BiH Central Election Commission or through the DCO BiH.
- (2) The representatives of political entities, associations and international observers shall complete a list of nominated observers, containing name, last name, country that issued the passport, passport number, number of valid ID card and national identification number, as well as the rules of conduct form and the statement on respecting secrecy of the vote for each nominated observer respectively.
- (3) In the application form the representatives of political entities, associations and international observers shall indicate in which DCOs BiH, designated for voting, they wish to observe the voting process.
- (4) In addition to the obligations set forth by the BiH Election Law and this Instruction the accredited observers shall be obligated to follow specific safety procedures relevant to the work of the DCOs.

## Section E. THE CRITERIA FOR ACCREDITING OBSERVERS OF POLITICAL ENTITIES AND ASSOCIATIONS

#### Article 7

## (Criteria for accrediting political entities and associations – Article 17.4 and 17.5 of the BiH Election Law)

- (1) Political entities and association may propose for observers only persons who are citizens of BiH and are 18 years of age.
- (2) The BiH Central Election Commission shall reject the application for accreditation of a person:
  - a) who is a candidate at the forthcoming elections;
  - b) whose candidacy at the forthcoming elections was rejected or his/her name was subsequently removed from the list of candidates;
  - c) to whom the BiH Central Election Commission pronounced the sanction of illegibility to work at a polling station committee, Center for voters' register or at an election commission,
  - d) who was proposed by a political subject that is not certified to participate at the elections;
  - e) who is member of a polling station committee;
  - f) who holds a mandate in the executive or legislative government in the constituency at the level for which he/she is standing for the elections (for municipal council and municipal mayor at the local election, and for the higher levels of authority for the General Election).

## CHAPTER III. DEADLINES FOR SUBMITTING AND RESOLVING REQUESTS FOR ACCREDITATION

#### **Article 8**

## (Deadlines for receiving and examining applications for accreditation - (Article 17.7 of the BiH Election Law)

- (1) The deadline for submission of the application accreditation shall start on the day elections are announced.
- (2) The final deadline for submission of the application for issuing accreditation to political entities and associations is fifteen (15) days prior to the Election Day.
- (3) Competent election commission shall take a decision on applications referred to in paragraphs (1) and (2) of this Article no later than ten (10) days following submission of the application.
- (4) The final deadline for submission of request for accreditation of international observers is seven days prior to the Election Day, and exceptionally the BiH Central Election Commission may approve a request for accreditation a day prior to the Election Day.

# CHAPTER IV EXAMINING APPLICATIONS FOR ACCREDITATION OF ELECTION OBSERVERS (Article 17.10, paragraph (2) of the BiH Election Law)

### Section A. Applications of political entities

## Article 9 (Examining the applications of political entities)

- (1) The BiH Central Election Commission shall distribute accreditation application forms to the head offices of every political subject.
- (2) Political entities shall submit completed accreditation application forms to the BiH Central Election Commission and to the election commissions, depending on whether they wish to be accredited to observe work of the Central Election Commission and work of Main Center for Counting or to observe work of the election commission, Center for voters' register or work at the polling stations and other locations of electoral activities.
- (3) Upon receipt of an accreditation application form, the BiH Central Election Commission and election commission shall verify if a political entity is certified to participate in the elections in the electoral unit belonging to a basic constituency for which political entities had nominated their observers.
- (4) The verification referred to in paragraph (3) of this Article shall be made against the list of all political entities, delivered by BiH Central Election Commission, that are certified in the electoral unit belonging to a basic constituency for which political entities had nominated their observers.
- (5) BiH Central Election Commission and Election Commission shall retain the original sample of the application together with rules of conduct form and the statement on respecting secrecy of the vote. The copy of the decision on accreditation and copy of the rules of conduct form and statement on respecting secrecy of the vote shall be delivered to the political subject as an applicant. The decision of the election commission on accreditation of a political entity shall be submitted to the BiH Central Election Commission. List of accredited observers shall be delivered to all polling stations in the basic constituency to which the application refers. An observer shall be obligated to wear the accreditation.

- (6) The BiH Central Election Commission and election commission shall reject the application to issue the accreditation by a decision in the following cases:
  - a) if certification of a political entity was annulled;
  - b) if the proposed observer does not meet conditions referred to in Article 3 of this Instruction; and
  - c) if a person was already nominated, namely if he/she was accredited by other political entity or an association.

### Section B. Applications of associations

## Article 10 (Examining applications of associations)

- (1) The BiH Central Election Commission shall examine the applications for accreditation submitted by the associations, and if found that the association was founded or is sponsored by a political entity, or it was involved in any activities on behalf of the certified political entity, it may reject the application or can approve the application if found that the association is neither founded nor sponsored by a political subject or that it was not involved in any activities on behalf of the certified political entity.
- (2) The BiH Central Election Commission shall make a list of names of accredited observers attached to the decision on accreditation of associations, and is integral part therefor, delivering it to all election commissions of basic constituencies in which the associations are accredited.
- (3) Election commissions shall submit the list referred to in paragraph (2) of this Article to all polling stations in the basic constituency to which the application refers.
- (4) If an association fails to provide evidence referred to in Article 4 of this Instruction, the BiH Central Election Commission shall reject the request for issuing accreditation of that association.

### Section C. Applications of international observers

## Article 11 (Examining applications of international observers)

- (1) The BiH Central Election Commission shall on the day it announces elections forward the Decision on announcing the elections to the BiH Ministry of Foreign Affairs and other relevant bodies aimed at timely dissemination of the information about the Election Day and election observation to the international observers and the states with which BiH has diplomatic and consular relations.
- (2) The BiH Central Election Commission shall examine the application for accreditation of an international observer and it may reject the request if found that the international observer is involved in any activities on behalf of the certified political entity.
- (3) The BiH Central Election Commission shall make a list of international observers whose applications for accreditation were approved and shall distribute the list to all election commissions of basic constituencies in which the international observers are accredited.
- (4) If possible, the BiH Central Election Commission shall prior to the Election Day hold a briefing for the accredited international observers and shall then distribute information material for election observation in BiH.
- (5) If the international observers fail to present evidence referred to in Article 5 of this Instruction, the BiH Central Election Commission shall reject the application for accreditation.

### Section D. Observers at polling stations for voting in absentia and observers of mobile teams

# Article 12 (Observers at polling stations for voting in absentia)

- (1) Political entities may have access to the polling stations for voting in absentia, namely to the polling station in which voters are registered in the excerpt from the Central Voters' Register to vote for the constituency in which the political entity is standing for the elections.
- (2) Observers of associations may have access to the polling station for voting in absentia, namely to the polling station for which their application for accreditation was approved.
- (3) Political entities and association shall bear the responsibility to seek from the BiH Central Election Commission the information on the location of polling stations for voting in absentia that are situated in other basic constituencies. Political entities and association shall contact the election commission of basic constituency in which the polling station for voting in absentia is situated in order to accredit their observers.

# Article 13 (Observers of mobile teams)

Municipal/city election commissions shall prepare a work plan of the mobile team that shall contain its composition, working schedule and the route, which is delivered to an accredited observer upon his/her request.

### CHAPTER V. DESIGN, CONTENTS AND DELIVERY OF ACCREDITATION CARDS

#### Article 14

### (Design and contents of the accreditation cared – Article 17.6 of the BiH Election Law)

- (1) The accreditation card shall be rectangular in form and shall contain the following information:
  - a) In the upper part:
    - 1) Logo of the BiH Central Election Commission;
  - b) In the middle:
    - 1) Election Logo;
  - c) Below:
    - 1) Name and last name of accredited observer,
    - 2) Date of issuance and number of decision,
    - 3) Signature of authorized officer who issued the accreditation card;
  - d) next to the signature, in right corner:
    - 1) Stamp of the election commission issuing accreditation card, and
  - e) The type of the observer is indicated in the upper right corner:
    - 1) for political subject the mark "PS" is given together with the code delivered by the BiH Central Election Commission,
    - 2) for associations the mark "PU" with a number starting from number 1, and
    - 3) for international observers the mark "MP" with a number starting from number 1.

- (2) The accreditation card for political entities shall be white; for associations gray; and for international observers the accreditation card shall be light pink.
- (3) The information in accreditation shall be printed in languages officially used in Bosnia and Herzegovina, and in Cyrillic and Latin alphabet.
- (4) The reverse side of the accreditation shall have the following text: "During observation of election process, an observer shall not disturb electoral activities and he/she shall respect the secrecy of vote. During observation of electoral activities, an observer shall wear the official accreditation card and shall not wear any insignia or markings, which affiliate him/her with a specific political party, coalition, list of independent candidates, independent candidates and a candidate from the special list of candidates, representatives of national minorities."
- (5) Text from paragraph (4) of this Article shall be in English language on accreditation cards for international observers.

# Article 15 (Distribution of official accreditation to political entities)

- (1) The BiH Central Election Commission shall prepare official accreditation cards (hereinafter: accreditation) for observers of political entities accredited to observe work of the BiH Central Election Commission and the work of the Main center for counting.
- (2) The BiH Central Election Commission shall define design of the accreditation card and shall deliver the latter to the election commissions, and election commissions shall be accountable for issuing and delivering accreditation cards to all accredited observers of political entities in their basic constituency.
- (3) Accredited observers shall collect accreditations referred to in paragraph (2) of this Article in the election commission of the basic constituency in which they are accredited for observing, by presenting rules of conduct form and the statement on respecting secrecy of the vote.
- (4) During observing of electoral activity each observer shall be obligated to wear accreditation card.

# Article 16 (Distribution of official accreditation cards to associations)

- (1) The BiH Central Election Commission shall determine design of the accreditation card (hereinafter: accreditation cards) and shall deliver it to the election commissions, and election commissions shall be accountable for distribution of accreditation cards to all accredited observers of associations in their basic constituency.
- (2) When collecting accreditation, the representative of the association must present to the election commission signed rules of conduct forms and the statements on respecting secrecy of the vote of accredited observers.
- (3) Election Commission shall verify that the name of the association indicated in the statement corresponds to the name from the list of associations accredited by the BiH Central Election Commission.
- (4) The election commission shall provide as many accreditation cards as there were signed rules of conduct forms and the statements on respecting secrecy of the vote.
- (5) Accredited observer of association shall retain the signed rules of conduct form and the statement on respecting secrecy of the vote referred to in paragraph (3) of this Article, thus ensuring that the person

wearing accreditation card is the person who signed the rules of conduct form and the statement on respecting secrecy of the vote.

(6) During observing of electoral activity each observer shall be obligated to wear accreditation card.

## Article 17 (Distribution of official accreditation to international observers)

- (1) Accredited international observers shall collect the accreditation cards at the premises of the BiH Central Election Commission by the Election Day at latest.
- (2) During observing of electoral activity each observer shall be obligated to wear accreditation card.

### 

- (1) The BiH Central Election Commission shall be responsible to design and distribute the official accreditation to accredited observers to observe elections at polling stations in DCOs BiH designated for voting of BiH citizens.
- (2) Accredited observers referred to in paragraph (1) of this Article shall collect the accreditation cards at the premises of the BiH Central Election Commission or at the DCO BiH designated for voting.
- (3) An observer shall be obligated to wear the accreditation card during observing the elections at polling station designated for voting of BiH citizens at DCOs BiH

# CHAPTER VI. ACCESS OF ACCREDITED OBSERVER TO THE LOCATION OF ELECTORAL ACTIVITIES' OBSERVATION – (Article 17.1 and 17.2 of the BiH Election Law)

# Article 19 (Access of observer to location of electoral activities)

- (1) Upon arrival at the location of electoral activities' observation, an observer must present a personal identification document to an authorized person of the election management body.
- (2) The authorized person shall examine the observer's identification document with a photograph in order to confirm that the observer's name is indicated on the accreditation.
- (3) The authorized person shall record the name of the observer, name of the subject that accredited him/her and his/her accreditation number in the official log of the election management body, noting the time the observer arrived to, and, later on, the time the observer left the premises, in order to limit the number of observers to one observer at the same time at one location of electoral activities if he/she is an observer of political subject and association.
- (4) The officer shall retain the identification document until the moment the observer leaves the location of electoral activities. When leaving, the observer shall be obliged to inform the authorized person on leaving the premises, upon which he/she will receive the identification document back. When leaving the location, the observer shall retain his/her accreditation.
- (5) The number of international observers present at a polling station is not limited, but it must not affect regularity of the election process.
- (6) International observer may be accompanied by an interpreter at any place where he/she observes the electoral activity.

#### CHAPTER VII ACCREDITED OBSERVERS IN THE MAIN COUNTING CENTER

# Article 20 (Access of accredited observers to the Main Counting Center)

- (1) Accredited observers shall be allowed to observe the process of counting of votes and all activities that take place in the Main Counting Center, which shall be recorded in the record of attendance of accredited observers.
- (2) Observers of one political entity in the Main Counting Center shall have the right to ensure that their observers simultaneously observe all activities taking place in the Main Counting Center, where one observer shall be assigned to observe one activity in line with the provisions of the Rulebook on operations and organization of work and establishment of voting results at the Main Counting Center for the 2022 General Election.
- (3) Accredited observers shall be allowed to move around the Main Counting Center within the areas marked as zones they are allowed to access. There shall be personnel of the Central Counting Center in each shift, who shall be assigned to keep the record of attendance of accredited observers, disseminate information to observers, organize tours of the premises of the Main Counting Center and answer questions about specific activities taking place within specific sections and groups.
- (4) During the course of the tour of the Main Counting Center, the observers and visitors shall be required to adhere to the house rules and shall not be allowed to interfere in any way with the process of counting of votes and the ongoing activities, or disrupt the staff of the Main Counting Center in the performance of their duties.
- (5) All observers shall have access to the Book of Complaints of Accredited Observers and be able to use it to enter their comments, suggestions and observations.
- (6) In addition to administrative assistant, shift supervisors, department supervisors and group supervisors shall also be able to answer questions of accredited observers referring to specific activities conducted in the Main Counting Center, within their scope of competence. Observers in the Main Counting Center shall be able to refer to the management of the Main Counting Center for any other questions pertinent to issues stipulated under special acts issued by the management of the Main Counting Center.

#### CHAPTER VIII. REVOKING THE STATUS OF AN OBSERVER

# Article 21 (Reasons for revoking observer status)

- (1) The election management body shall revoke the status of accredited observer and remove the observer from location of electoral activities during observation of election process if:
  - a) observer interrupts electoral activities;
  - b) observer does not respect secrecy of voting,
  - c) observer does not wear official accreditation; and
  - d) observer carries insignia which affiliate him/her with a certain political party,

## Article 22 (Procedure of revoking the observer status)

- (1) In the process of removing an accredited observer from location of electoral activities, a representative of the election management body should first warn the accredited observer who is disrupting the electoral process and undertake all other available measures and actions to stop the disturbance, and if accredited observer continues such an action, the representative shall remove him/her from the location of electoral activities.
- (2) Competent election management body shall inform political subject, association namely international observer about the accreditation being revoked.

#### CHAPTER VIII. FINAL PROVISIONS

## Article 22 (Annexes)

Integral part of this Instruction are:

- a) AP-1-PS and AP-2-PS accreditation application forms for representative of political entities,
- b) AP-1-UG accreditation application form for associations,
- c) AP-1-MP accreditation application form for representatives of international organizations,
- d) AP-1-MP-E accreditation application form for representatives of international organizations in English language;
- e) (AP-1-IP) rules of conduct form and the statement on respecting secrecy of the vote;
- f) Design of accreditation for international observers;
- g) Design of accreditation for political entities; and
- h) Design of accreditation for associations.

## Article 24 (Ineffectiveness)

Enforcement of the Instruction on conditions and procedure for accrediting election observers in Bosnia and Herzegovina (Official Gazette of BiH, no. 37/14) and Instruction amending the Instruction on conditions and procedure for accrediting election observers in Bosnia and Herzegovina (Official Gazette of BiH, no. 29/18) shall become ineffective upon entry into force of this Instruction.

# Article 25 (Entry into force and publication in Official Gazettes)

This Instruction shall enter into force on the day of its publication in the Official Gazette of BiH, and it shall be published in the Official Gazette of Federation BiH, Official Gazette of Republika Srpska, Official Gazette of the BiH District of Brčko and webpage of the BiH Central Election Commission www.izbori.ba.
